FESTIVAL TURNED FLOOD: MANAGING THE UNEXPECTED

The first Lancaster Festival concert kicked off just as an epic 48-hour storm dumped nearly two months' worth of rain across Fairfield County. The festival, held annually for over 50 years, draws concerts

of up to 15,000 attendees. What is normally a well-oiled event quickly became a full-scale emergency response.

Fetters Run, the creek and watershed running through the grounds, surged, cutting off the stage and audience from the parking lot and road exit. Pedestrian bridges were overtopped and the only vehicle bridge became unusable. With 5,000 attendees on-site, early activation of the evacuation plan and tight communication got everyone safely to a shelter across the creek, prior to the flooding.

KEY TAKEAWAYS FOR LARGE EVENTS

- Plan early and know site-specific
- Ensure all agencies are familiar with your plan
- Maintain clear, continuous communication
- Always follow pre-determined action triggers
- Avoid reliance on a single entry or exit

DAVIS-BESSE RETIRING OUTDOOR SIRENS:

LUCAS & OTTAWA COUNTIES EMBRACE IPAWS FOR MODERN EMERGENCY ALERTS

Ottawa and Lucas Counties, in partnership with the Davis-Besse Nuclear Power Station, are transitioning away from outdoor warning sirens (OWS) as the primary alerting method within their shared Emergency Planning Zone (EPZ) around the Davis-Besse Site. To enhance public safety, the counties are adopting the IPAWS and Wireless Emergency Alerts (WEA) as their primary methods of public notification.

This transition has been formally approved by the FEMA and the Nuclear Regulatory Commission (NRC) as an effective alternative to traditional outdoor sirens.

A Joint Approach to Modern Alerting

Ottawa and Lucas Counties share alerting authority for IPAWS. This collaboration allows both counties to issue emergency alerts seamlessly across jurisdictional boundaries, ensuring fast, consistent, and coordinated messaging to all residents.

This shift reflects a growing national trend toward modern, digital emergency alerting — moving systems that offer broader reach, faster delivery, and greater accessibility.

Why Move Away from Sirens?

OWS have served communities well for decades, but they have significant limitations:

- They are only effective outdoors
- · They cannot provide detailed instructions or context
- They do not reach people who are indoors, asleep, or in vehicles

In contrast, IPAWS sends alerts directly to mobile phones, reaching people wherever they are and delivering timely, actionable information in real time. It's like having a siren, and detailed emergency info, in your pocket.

Monthly Testing in Ottawa & Lucas Counties

To ensure the alert system is functioning properly, Ottawa and Lucas Counties will continue to conduct a monthly WEA test on the first Friday of each month at 12:00 PM. These tests coincide with the legacy outdoor siren tests, provide a seamless transition experience, and reinforce public awareness of the new system

Important Reminder:

To receive test alerts, individuals must enable test alerts on their phones (usually found in the "Emergency Alerts" section under notification settings).


What Emergency Managers Should Know

- This FEMA and NRC-approved transition to IPAWS ensures compliance with federal emergency preparedness standards.
- Shared alerting authority between Ottawa and Lucas Counties strengthens cross-county coordination.
- The new system significantly improves safety, speed, and accessibility during critical events such as:
 - Radiological emergencies
 - Severe weather (e.g., tornado warnings)
 - Hazardous material incidents
 - Local evacuations

Monthly coordinated testing supports system reliability and provides opportunities for training, public engagement, and continuous improvement.

This transition represents a major advancement in regional emergency preparedness. Ottawa and Lucas Counties are setting a strong example for how jurisdictions across Ohio can modernize public warning systems - ensuring faster, smarter, and more inclusive emergency communication.


